
Dear Sir,

**Conditions**

- (b) he will not be allowed to take his salary or a part thereof in foreign currency;
- (c) he will not be allowed to stay abroad more than the approved period;
- (d) he will leave Dhaka on 11 May, 2018 or a date close to it and return to the country on 19 May, 2018 or a date close to it from Geneva Via London.

2. This order has been issued by the approval of the competent authority.


